MEMBERSHIP MEETING MINUTES HYBRID MEETING - CENTURY ENGINEERING

March 17, 2022 Prepared by Dora Parks, Secretary

CALL TO ORDER AND INTRODUCTIONS

- President Lyon called the meeting to order at 9:05am.
- There were 21 attendees.
- Introductions were made by all attendees.
- A motion to approve the meeting minutes dated February 17, 2022 was made by CJ Myers and seconded by S. Keyser, motion carried.

PRESENTATION

Jim Barron (E.D. MD Authority) presented on the SB877 Temporary Excavator" (TE) which became Maryland law in March 2021. A primary contractor initiating a new ticket number may add a TE to their ticket during the ticket processing or after the ticket has been released to affected members as long as the ticket number remains valid. This processing option is not available to homeowners. Under MD law, the primary contractor/excavator takes full responsibility for work done by their named and accepted by, TE. For every new ticket number issued, if a TE is required, the Primary is required to complete all related fields naming the TE and the TE much agree to being added by the Primary.

Processing a TE notice became effective for Maryland tickets on Feb. 23, 2022. This type of ticket does not display a special header. Jenn. Arroyo (OCC GM) stated a subsequent notice will be released by the call center clarifying the duties and procedures for primary contractors/excavators selecting this ticket processing option. President J. Lyon requested future ticket volume data for this particular option and information on any arising known concerns or issues.

EXCAVATOR/MEMBER/LOCATING CONCERNS

- R. Cleveland (Chesapeake) voiced concerns regarding Comcast ticket issues. The BOD suggested Rick Kerfoot be contacted to review the issues.
- B. Mooney (Tidewater) stated his locators raised concerns regarding emergency ticket response on what they believe are false emergency ticket processing. A group discussion ensured regarding;
- DE Law the emergency ticket has the same locator response time as a standard ticket, understanding some utility members respond in less than 48 hours.
- A probable law violation can be reported to the DE PSC or the MD Authority (processing fee imposed)
 using the respective website.
- Poor planning on the part of the member or contractor, creating a perceived emergency condition.
- Contractors jumping on the emergency bandwagon as there seems to be no enforcement.
- Utility members as emergency processing offenders.
- Suggestion, the BOD to send a letter to the offenders.

W. Ericksen (DE PSC) stated the DE PSC website damage report and notice of probable law violations reports using the new codes are working to better understand damage root causes.

- B. Cahall (Easton Utilities) stated CATV locators are not identifying their located painted marks. DE Title 26, 803 - Duties of the Operator 5, a. (Page 47 of handbook) states; ...and how to identify the markings.
- CJ Myers (DEC) shared the current issue from the Dept. of Agriculture regarding access to to chicken farms due to the Avian Flu and how DEC is handling chicken farm locates.

CJ provided the following:

Avian influenza, or "bird flu," is a virus that infects domestic poultry, such as chickens, turkey, quail, and geese, and wild birds such as shorebirds and waterfowl. There are no human health concerns from the strains of avian influenza that have been reported in the United States. Avian influenza is a serious disease concern for poultry producers and animal health officials. While influenza strains in birds, just as in people, vary considerably in severity, some influenza viruses can be devastating to domestic poultry.

By request of Michael Scuse, Secretary of the Delaware Department of Agriculture, DEC is limiting its visits to chicken farms.

For DEC locating, we are only going on-site after speaking with the owner. If we do not speak with the owner we will not be going on site. For the case of emergency locates like the one that came in last night for an infected farm, we have made up PPE kits that we will have at different locations. Below is a sample of what the DEC kits contain that includes specific locator PPE;

- L/XL Tyvek suit with boot covers
- 2XL/3XL Tyvek suit with boot covers
- Disinfectant spray
- Trash bag
- Gallon pump up sprayer with water in it
- Gallon of bleach

<u>Delaware</u> - Wayne Ericksen (DE PSC) reiterated damages and violations of the Underground Utility Damage and Safety Act can be submitted at; https://depsc.delaware.gov/ and noted that member damage reporting to the USPCD do not automatically go the DE PSC.

OLD BUSINESS

Jenn Arroyo reminded the general membership that the **Maryland** law change (SB789 and HB 994) to allow the excavator to provide their work site start date from the 3rd business day to the 12th business day will go into effect on June 1, 2022. Based on the provided and recorded start date, the ticket expiration date will be extended, this will be reflected on the ticket. This new law hopes to improve the utility locate on-time performance allowing excavators to begin their work as planned.
