# Minutes of the December 21, 2017 Membership Meeting

#### 1. Call to Order and Introductions

- ➤ President Brad Ebaugh opened the regular membership meeting at Artesian Water, 644 Churchmans Rd., Newark DE 19702.
- Mission Statement: Our mission is to assist excavators, facility owners, and the public in the prevention of underground damages, service outages, personal injury, and their associated repercussions, through education and the promotion of the One Call System.
- ➤ 22 members were present.
- > Those present gave the customary introductions.
- > Tony Gersitz made a motion to approve minutes as amended, Steve Keyser seconded, unanimously approved by the members.

# 2. Presentation- Brad Ebaugh, President, Miss Utility: Holiday Safety

- ➤ Road work, especially in the dark, is especially dangerous. Use flashers and traffic control to remain safe. The holidays are a distraction for many people.
- > Mr. Ebaugh reviewed the monthly damage statistics:
  - o DE: 12716 tickets, 7 damages
  - o 22 Members responded, 18%
  - o MD: 9078 tickets, 15 damages
  - o 15 Members responded, 16%

#### 5. General Locate Issues

- ➤ Jason Lyon, City of Dover: Electric was replacing a sewer lateral running through an electric substation. The sewer lines are owned by the City. A private locator was utilized to mark power plant lines, but the electric lines were not on city drawings. A potentially dangerous situation was averted by the use of vacuum excavation, instead of a backhoe. Also, a grounding grid affects locating devices.
- ➤ Mark Gemmill, Tidewater Utilities: Felton DE: Comcast ran a line to one house, not on Comcast records. Facilities need to be added.
- Wendy Stack, W. Locco: Queen Annes County, MD- problem with sewer lateral work. Excavator not waiting for ticket to be marked (same day digging). Not responding to our concerns.
- ➤ Jerry Platt, DE PSC: Nobels Pond, Cheswold, DE. The owner of the property also owns utilities. Gas lines are not being located. Send concerns to the board of Miss Utility. The utility is responsible for depth, even after installation.
- ➤ Brad Ebaugh, DEC: Verizon clearing tickets. The electric coops. in VA/MD/DE are compiling data regarding the cost of waiting for marks. Delaware has been aware since 2015 and we have discussed filing discrepancies if there is evidence of VZ. John Hughes, VZ says they have 3 hrs. to respond to a discrepancy in VA.
